We advise that in its meeting today, our Board of Directors approved the declaration of the cash dividend for holders of its voting preferred shares payable on December 4, 2015 to shareholders on record as of November 24, 2015.

The amount of the cash dividend will be based on the average 30-day PDST-R2, as computed by the Philippine Dealing and Exchange Corporation (PDEX) plus 2%. The aggregate dividend payment for the voting preferred shares is about ₱33 million.
