## Globe Telecom closes term loan with Bank of China (Hong Kong) Limited

Globe Telecom, Inc. signed a term loan facility with Bank of China (Hong Kong) Limited for US\$100 Million. The loan shall be used to finance the Company's capital expenditures.

Globe spent Php19.1 Billion in capital expenditures as of end-March 2021, exceeding last year's spending by 79%. Around 91% of the investment went to data-related requirements to support the fast-growing data usage and provide superior data customer experience. Globe expects to spend a new record of Php70.0 Billion for capital expenditures in 2021.
