NOTICE

Notice is hereby given that on 09 December 2025, a sworn Registration Statement (“RS”) was filed with the Securities and Exchange Commission (the “Commission”) on behalf of **GLOBE TELECOM, INC.** (the “Company”) covering the shelf registration of up to **TWENTY MILLION (20,000,000)** cumulative, non-voting, non-participating, non-convertible, redeemable, and Philippine Peso-denominated perpetual preferred shares with a par value of Fifty Pesos (PhP50.00) per preferred share to be offered in one or more tranches, or one or more series per tranche at the discretion of the Company, under a securities program (“Non-Voting Preferred Shares Program”).

The first tranche of the securities program constitutes **SEVEN MILLION FIVE HUNDRED THOUSAND (7,500,000)** preferred shares with an oversubscription option of **up to FIVE MILLION (5,000,000)** preferred shares at an offer price of **Two Thousand Pesos (PhP2,000.00)** per share, to be listed and traded on the Main Board of the Philippine Stock Exchange.
